Installation Instructions

- · Directly connect to the HDMI host source
- . Optional: Connect the USB cable to boost the video signal
- Connect a DisplayPort cable (sold separately) in the shortest length needed
- · Find a compatible video resolution between the host and output display
- · Adjust the audio from the host and display menu selections

Troubleshooting Tips

- · Reboot the computer and connect the USB power cable
- 4K@30Hz video requires compatible equipment and a DP 1.1 monitor setting
- Test with a different DisplayPort cable and output display
- · DisplayPort host to HDMI display is not supported
