Installation Instructions

- · Connect the adapter directly to the USB-C/Thunderbolt 3 port of the host
- Optional: Connect a USB-C charging cable to the adapter and a charger Note: Do not remove the charging cable while the adapter is in use
- · Connect a DisplayPort cable (sold separately) in the shortest length needed
- Find a compatible video resolution between the host and the output display
 Note: 4K video resolution requires a 4K source and 4K-rated DisplayPort cable

Troubleshooting Tips

- DisplayPort Alt Mode (video over USB-C) must be supported by your device
- Test with a different DisplayPort cable and output display
- . Try a different USB-C/Thunderbolt 3 port on your device
- . Unplug everything, connect the USB-C power cable, DP cable and adapter
- Check for updated USB-C/Thunderbolt 3 drivers for the computer
