# USB Type-C™ to HDMI® Adapter

## Installation Instructions

- Connect the Adapter directly to the USB-C/Thunderbolt 3 port of the host device
- Optional: Connect a USB-C charging cable to the adapter and a charger  
Note: Do not remove the charging cable while the adapter is in use
- Find a compatible video resolution between the host and output display  
Note: 4K video resolution support requires a 4K-rated source and HDMI cable

## Troubleshooting Tips

- DisplayPort Alternate mode must be supported by your device for video
- Test with a different HDMI cable and output display
- Try a different USB-C/Thunderbolt 3 port on your device
- Unplug everything, connect the USB-C power cable and then the adapter and HDMI cable
- Your computer may need updated Thunderbolt 3 drivers
