## USB-C™ to DisplayPort™ Adapter in Aluminum Housing

### Installation Instructions

- Connect the adapter directly to the USB-C/Thunderbolt 3 port of the host
- Connect a DisplayPort cable (sold separately) in the shortest length needed
- Find a compatible video resolution between the host and the output display
- Note: 4K video resolution requires a 4K source and 4K-rated DisplayPort cable

### Troubleshooting Tips

- DisplayPort Alt Mode (video over USB-C) must be supported by your device
- Test with a different DisplayPort cable and output display
- Try a different USB-C/Thunderbolt 3 port on your device
- Check for updated USB-C/Thunderbolt 3 drivers for your device
