Installation Instructions

- · Connect the SOURCE DisplayPort Cable to the INPUT port
- Connect the MONITOR DisplayPort Cable to the OUTPUT port
- · Plug the Micro-USB charging cable to a USB 3.0 port or 1A USB wall charger
- · Power-on the source equipment and monitor
- Adjust the audio and video settings on the source and monitor
- · Test the equipment before surface mounting with the integrated screw keyholes

Troubleshooting Tips

- DP Repeater requires USB power for operation
- . Check that the DP cables are connected to the correct INPUT and OUTPUT ports
- Directly connect the source and monitor as a test for compatibility
- Check that the LED is lit on the DP Repeater
- 4K@60Hz video requires a DP 1.2 cable
- 8K@60Hz video requires a DP 1.4 cable
- Maximum distance for 4K@60Hz is 80ft (45ft In/35ft Out)
- Maximum distance for 8K@60Hz is 32ft (16ft In/16ft Out)
